#### **Administration:**

Tucker has completed the documents for every firefighter and all but one met the requirements for 2017 Qualifying Pension/Firefighter in Good Standing. The individual who did not qualify did not attend enough training in 2017.

## **Operations:**

All but one tire has been installed on E-414. The old tire is on E-414 and the engine is in service. A part for the automatic inflation/deflation system is needed. The original quote on these tires was \$650/tire, but the department was only charged \$450/tire plus mileage and labor.

Combi tool has been in service since last Friday.

The new 418 pickup is on the Front Range to be set up, but no other update is available.

## **Grounds:**

The interior lighting upgrade has been completed. The rebate for the installed LEDs is expected to be just under \$500 and given as a credit on the electric bill from Mountain Parks Electric.

## **New Business:**

Twelve Survivair Carbon Fiber bottles and 12 valves were traded into Dalmation Fire Equipment in Eaton, Colorado. Dalmatian is issuing Kremmling Fire a credit of \$920 for the equipment. In return, 5 bottles can have their life extended for another 15 years for \$300/bottle, which will have a final cost of \$580 for the District. The one company that can recertify bottles is located in Centennial, Colorado. A new bottle costs at least \$1,000. The recertified bottles will need to go in for testing every 5 or so years to be valid.

Summit Fire & EMS may be interested in other equipment that the District has: a valve that turns a spike in a bottle to a threaded attachment and 10 bottles (4 with spikes and 6 with threads). Tucker offered all the equipment to Summit Fire for \$2,000 and will wait to hear for management's decision if they agree with the deal.

No new recruits for this year. During the day, we don't have many volunteers available to go on runs, but the District is able to respond appropriately to calls and has equipment that replaces manpower.

Mathis will be heading up an advanced class soon. A couple of the newest firefighters just need a couple more items until they earn their black helmets, which will have been accomplished in less than a year.
